#### 1. General

The protection of your personal data is very important to us. We treat your personal information with the strictest confidentiality and in accordance with the applicable data protection regulations and this privacy policy. # 2. Participation

However, revocation before participation in the health measure will make participation impossible. Stored data can only be viewed and processed by authorized persons.

The web application "GiB-Base", which acts as a registration platform and manages the registrations, is operated by GiB GmbH on a dedicated server in a data center operated by Hetzner. This data center is located in **Germany** and is certified in accordance with DIN IEC 27001.

# 4.1 Revocation of your consent to data processing

Some data processing operations are only possible with your express consent. You can withdraw your consent at any time. An informal notification by e-mail (info@gib-gesundheit.de) is sufficient for the revocation. The legality of the data processing carried out until the revocation remains unaffected by the revocation.

# 4.2 Right to lodge a complaint with the competent supervisory authority

As a data subject, you have the right to lodge a complaint with the competent supervisory authority in the event of a breach of data protection law. # 4.3 Right to data portability

## 4.4 Right to information, correction, blocking and deletion

You have the right to free information about your stored personal data, the origin of the data, its recipients and the purpose of the data processing and, if applicable, a right to correction, blocking or deletion of this data at any time within the framework of the applicable legal provisions. ## 4.5 SSL or TLS encryption

For security reasons and to protect the transmission of confidential content, there is SSL or TLS encryption of the GiB employee's end device during the time of execution. This means that data that is transmitted cannot be read by third parties.
